### VII. Course Requirements

Attendance: Since some material will only be presented during class (e.g., videotaped material, class discussions, some lecture material, and all presentation material), regular class attendance is expected. If you must miss class, it is your responsibility to find out what was covered in class and if any announcements or assignments were made. You will be expected to complete assigned readings before class. For those of you who attend class regularly, your class attendance may also be used as a factor at the end of the semester in rounding grades up that are fractionally close to the next highest grade. Students who miss 2 or more classes will receive a failing grade for the semester. Students who are 15 minutes or more for any given class will be marked absent for that day.

**Participation:** Student participation is a normal expectation. Classes will cover material both in the textbook and outside of the textbook. This material is better understood with all students interacting in the process. You are expected to engage the material, professor, and each other in a professional manner. You should ask questions, throw out ideas, and respond to your classmates' ideas. The class experience can be enhanced with everyone's participation, so please come prepared to discuss material.

**Research Participation:** This course includes a research experience requirement that is meant to expose you to a wide variety of psychology research either through participation, ethics training, and/or reading the literature. This requirement is worth 5% of your final class grade. You must complete a total of 5 hours (1 hour per 1% credit) to earn the full 5%. You may do so by completing any combination of the following:

- 1. Participating in a study: Available research projects can be found on the research participation website: <a href="https://nova.sona-systems.com/Default.aspx?ReturnUrl=/">https://nova.sona-systems.com/Default.aspx?ReturnUrl=/</a>. All research projects available to you will post the expected participation time to the nearest half-hour. One hour of research participation equals 1 hour of research credit; you may earn up to 5 credits by participating in a research study.
- 2. Carry out Online Human Subjects Training: You may partially fulfill the research participation requirement by completing an online human subjects training activity. This entails passing all nine module quizzes from the College of Psychology, Department of Psychology and Neuroscience' CITI training course with a 75% or greater score. This option must be completed in full to get the maximum 2 credit hours (you will need to either participate in a study or write papers to make up the remaining 3 credit hours). - 3. Write up a review of a research article: You will choose an article from an approved journal and write-up a 1-2 page analysis of the paper. One article analysis equals 1 hour of research credit; you may earn up to 5 credits by writing up to 5 article analyses. **Exams:** Two Exams will be given during the term. Exams will include materials from assigned readings, lecture material, and/or materials contained in video. Tests will consist of multiple choice, short answer, and essay questions.

**Paper:** Each student will be expected to write a course paper and present their findings to the class. The research paper must be on some aspect of forensic psychology. The paper should be 3-5 pages in length and should conform to the APA publication guidelines. Students should clearly define major clinical psychology points throughout their paper. The topic of the paper must be pre-approved prior. In addition, students are expected to make a 10-15 minute presentation as part of this assignment. The presentation will be on the paper and should involve multimedia and class discussion.

**Exams:** Two Exams will be given during the term. Exams will include materials from assigned readings, lecture material, and/or materials contained in video. Tests will consist of multiple choice, short answer, and essay questions.
